- 1. Introduction
  - a. Judy Tortelli welcomed the group and started the 12th design review meeting.
- 2. Utility Coordination
  - a. Judy is preparing letters for the utility companies
  - b. Kaci will provide utility specific information for individual letters and will get sent out next week
- 3. Environmental Update and Commitments
  - a. Section 408 for overall project to be submitted next week; there are a few updates being made to the hydraulic model based on CTWCD review
  - b. NDEP 401 Certification Preplanning meeting scheduled for 4/13 with Zack Carter Geotechnical Boring
- 4. 60% Review Comments
  - a. City of Reno provided this morning
    - i. Fire truck turning movements still owed to City
      - (Kaci provided AutoTurn movements to Khalil with DRAFT design exception memo on 4/15)
    - ii. Drainage specific review meeting requested by Teresa; Joe and Teresa have not provided any comments yet; hope to provide by 4/18
    - iii. Will coordinate discipline specific comment review mtgs with City, Khalil thinks Park specific meeting may also be necessary
    - iv. Joe C. asked about Kayak Park, if specific report for; Judy explained RTC hired them directly, they are catching up, need survey when water levels allow, will catch up at 90% submittal
    - v. Joe C. asked about Kayak Park timing and contractor; Judy explained RTC will include the Kayak Park plans as part of the Arlington Project and work will be done at the same time by the same contractor.
    - vi. Khalil asked about review of bridges does CoR need to hire a review consultant?
      - Jessen at NDOT has reviewed, and will continue to review
      - Independent QC of bridge final design is part of Jacobs rigorous QC process
  - b. TRFMA
    - i. Eric Scheetz: The project is NOT financially partnered with TRFMA
    - ii. TRFMA has just providing reviews and comments
    - iii. Teresa and Joe from CoR, and Judy/RTC, requested comments on 60% submittal from TRFMA
  - c. NDOT
    - i. John L'Etoile needs a new link to download the plans (old one expired) (Robbie sent 4/11 after the meeting)
    - ii. Will provide comments in 1 week
- 5. 90% Design Updates

#### a. Formliner

- i. Robbie asked if Public Art Input is still desired, if so we need to reach out to Megan Berner (City of Reno)
- ii. Judy responded Yes, we have discussed formliner internally and Barb S. will reach out to begin coordination with Megan
- iii. Judy is requesting formliner decision by the end of the year (90% submittal beginning of October)
- iv. Judy says to keep the center pier formliner we have rendered, this will provide a baseline for the public artists to coordinate with.
- v. Artists need to have formliner experience; invite Vicki Scuri, Siteworks, (who did formliners for Meadowood Mall Interchange
- vi. Graffiti coating is required (no color); works well on Virginia Street Bridge

- i. Railing needs to be removal (Matt Brezenia wants it removable for floods)
- ii. Structural details all in progress

- i. Meeting with City of Reno arborist on 4/13
